This module introduces you to knowledge in global health and the determinants of health operating at local and global levels, health inequalities as well as key issues and strategies for protecting and promoting the health of populations in various global settings.

20 Overview of the Module

You will develop a keen understanding of key global health issues including health determinants, the global burden of disease, health inequalities, strengthening of health systems, global health policies and politics as well as the various strategies used to promote and protect health. You will also develop skills in critical thinking, analysis, collaboration, communication and working with evidence to provide innovative solutions that can help improve health systems. The programme will use a range of learning approaches including the virtual classroom, flipped and peer learning, recorded lectures and threaded discussion boards. Your learning will be supported by a range of online teaching methods that include directed and self-redirected learning, group work, case studies and threaded discussion boards. These tools will also be used to provide you with continuous formative feedback. Importantly, you will benefit from access to staff involved in LSTM's global health research programmes (e.g. drug resistance, gender and health, neglected tropical diseases, climate change, lung health and TB).

20 Overview of the Module

In this module you will cover key aspects of qualitative and quantitative research methodologies. This includes a critical discussion of the different theoretical basis underpinning quantitative and qualitative approaches, study designs, methods, ethical issues, data management, analysis and interpretation. The module will use a range of learning approaches including the virtual classroom, flipped and peer learning, problem-based and experiential group work, recorded lectures, case studies, research papers and threaded discussion boards. The use of multiple-choice questions and practical exercises will also be used throughout the course to provide you with continuous formative feedback in basic statistics and key principles of qualitative research. Your learning is supported by a range of interactive online teaching methods and self-directed learning opportunities, group work, case studies and threaded discussion boards. You will benefit from the global health research and teaching expertise within LSTM.

20 Overview of the Module

You will be introduced to various key concepts in leadership including, governance, health systems, systems thinking, quality improvement, service development and efficiency measurement. Different leadership theories will be critically discussed, with case studies presented to facilitate group discussions on the practical application of concepts to various scenarios. You will also gain knowledge on how leadership influences the planning, functioning and structuring of local and global health systems. The module is taught using student-centred approaches that includes virtual classrooms, online group exercises, chat rooms, blogs, case studies, self-directed and directed reading and recorded presentations from experts in global health systems leadership. The online exercises will provide you with continuous formative feedback. You will keep a reflective diary that documents your learning throughout the module. Your reflections in the diary will contribute towards assessed reflective summary.

20 Overview of the Module

This module equips you with the knowledge and more advanced practical skills in quantitative approaches that are important for the detailed exploration of global health issues. You will have the opportunity to work with epidemiological datasets, plan a strategy and conduct more advanced statistical analyses of the data using appropriate statistical software. You will also learn how to interpret and present the results. Teaching sessions typically comprise pre-recorded presentations and exercises. You will experience a range of learning approaches including the virtual and flipped classroom, problem-based group work, recorded lectures, case studies, research papers and threaded discussion boards. You will benefit from the global health research and teaching expertise within LSTM.

The module will develop your 'deeper' understanding of key concepts in qualitative research, so you can critically appraise qualitative research and have the skills to conduct and commission qualitative research in various health contexts.

20 Overview of the Module

The module (re)introduces you to the theoretical and practical aspects of qualitative approaches in various global health topics. You will learn the practical aspects of qualitative research, including theoretical approaches, selection of research topic, methods (interviews, ethnography, observations etc.), ethics, data collection, transcribing, data analysis, presentation and communication of results to diverse audiences. You will critically discuss, with examples the contextual and contested nature of research ethics and the importance of being a reflexive practitioner. Topics such as critical review, quality, rigour and trustworthiness will be covered. The module will be taught using student-centred, problem-solving online approaches, including virtual classrooms, recorded lectures, discussion boards, videos, and peer assessments. You will also have the experience of learning from world class qualitative research conducted by LSTM academics.

This module aims to provide you with knowledge and critical understanding of the effects of global climate change on human health and the impact of these changes on livelihoods. You will also explore options for mitigation and adaptation.

20 Overview of the Module

Climate change is one of the greatest challenges facing the World in the 21st century and this module will look at its wider impact on lives and livelihoods across all continents. You will explore the economic, political, social and environmental determinants of vulnerability to the effects of climate change and will be encouraged to examine critically, the key strategies of adaptation and mitigation. Taking a student-centred and problem-solving approach to facilitate deep learning, core information will be presented through several online platforms including recorded lectures, threaded discussion boards, chat rooms and this will be expanded through case studies, group work and online seminars and group discussions. You will benefit from a learning environment that is embedded in LSTM global health research. The module is assessed by a 2000-word critical essay, a group presentation and an individual reflective essay. You will be able to write the main critical essay on whatever aspect of the module interests you most, following consultation with, and approval from the module leader. The topic may focus directly on health issues but may also revolve around other areas of concern related to climate change that have an indirect link to health. You will keep a reflective diary that documents your learning and achievement of the competencies and skills. Your reflections in the diary will contribute towards the assessed reflective summary.

20 Overview of the Module

The interaction between the local and the global context of health is complex due to diverse socio-economic, cultural and political contexts. This module will give you different perspectives on the social determinants of health at the global and 'local', community levels within the context of the 'global' language of the right to health. The module will include exploration of how local contexts influence individual experiences of health and illness and the implications of this for global health practice. You will develop an understanding of 'culture' in health and the application of equality and diversity frameworks in a wide range of global health settings. The module will use a range of learning approaches including the virtual and physical classroom, flipped and peer learning, problem-based and experiential group work recorded lectures, case studies, research papers and threaded discussion boards. These interactive tools, including research papers, case studies and videos will be used throughout the course to provide you with continuous formative feedback on the application of social science concepts and human rights in understanding global health issues. You will benefit from the global health research and teaching expertise within LSTM. Your learning is supported by a range of online teaching methods that include directed and self-redirected learning, group work, case studies and threaded discussion boards.
